2. Progress – success and setback

Since we had to start over with new members of the Board of Directors and oversee executed work, such as making it more efficient, but too, easy to handle for poor with none or poor education, we have found both strength among some of our members how to carry out the work, but too, found weaknesses in the system, and as well experienced how the impact on the environment as the mining does also strike our abilities to reach out.



Initially when we started over with new regulations back in 2009, we saw a brighter future also in the attitude which was shown from some stakeholders caring for the Mamanwa tribe.

This have now confused us since it has been proclaimed from the regional director of NCIP in 2012 that some of the very officers in local NCIP offices, has shown fraud and opposed the laws and conditions set by the Government to help tribal in the Philippines.

While this occurred, even Taganito Mining Corporation executed an order to resettle the northern Mamanwa tribal group from Taganito, Claver, to Punta Naga. Punta Naga is a place near the sea where labours of the TMC has been living. But new settlements for the employed have been built higher up in the mountains while the whole Mamanwa group has been resettled hereto.

On investigation by Thor Klaveness when he has met representative from TMC CRO Department, Mamanwa and NCIP, as well as people in the surroundings, it has shown that the Mamanwa group never has agreed to move to Punta Naga. Still, TMC claim that this is the original settlement for the people of Mamanwa, something that they highly oppose.

It is a fact, however, already written in Philippine history, that Mamanwa tribal are nomads, and normally found in the mountainous regions, since their livelihood is from the forest and not from the sea.

According to reports shown in Philippine media throughout the year, it has been told that NCIP officers together with local politicians and Mining representatives have falsified documents, which instead of telling the true story of tribal ancestry domains, tell wished ancestry domains by the mining companies.

This type of counterfeit may, as a result, give that the tribal, as now happen, when the open pit mining is finished one place, and the mining company need their present location for new open pit mining fields, they need to move to a place they are not familiar with.

The trick the mining company use is that they already have moved the tribal several times, and during the many times a transfer has been made, the tribal leaders have been cheated to sign a document pointing to an "origin" place as ancestry which is not.

It is much easier, and too, cheaper for the mining companies to restore a place near the sea, since it is common sense among Filipinos that all people live by fishing as livelihood.

Knowledge about the tribal livelihood and their local knowledge on tropical forests are mainly unknown among the Philippine population, why the

tribal get hardship to prove that they have been moved eventually by force.

At least us, since we have been participating in the work of assisting Mamanwa, have followed the progress since 2004 until now, and seen different solutions in the provinces of Surigao, both on the side of political support as on the side of the tribal efforts to come along.

It is not equal efforts and the tribal have no budget to invest for their wellbeing. It is said that there are funds, but yet not used by Mamanwa directly since they are not seen matured enough to handle these funds.

NCIP which have had the supervisory and advisory responsibility has too been infected by fraud crew, as reported above. We must remember too that these crew which has been found not able enough to work within NCIP, have not been dismissed from the organization, but "replaced", yet in the office and yet able to provoke present officers. Who know if present officers will sustain on the legal curriculum or if they will engage eventually in the common corruption, which is a part of the lifestyle in these provinces where education is low?

That the government in addition to this tells investors, both domestic and international that Mindanao is dangerous, does not lift the situation to a better level. It is time now to highlight among all international investors if there can be successful to divide Mindanao into sectors in which various measures can be implemented for a better sustainability. As far as we have been involved the last seven years, it is not the population of Mindanao who carry the danger, but its politicians. They are unfortunately more present outside Mindanao than on Mindanao! This is why a blockade of Mindanao is not a solution.

In late 2011 Mamanwa in Taganito was asked to totally destroy their own settlement before they moved to their new settlement in Punta Naga.

This was said to the reason that some Mamanwa tribal would move back, which would be dangerous to them since TMC now intend to use this area for their mining again.

The contradiction in this statement is that Mamanwa themselves say they will get 10 to 15 km longer way to their ancestral domains where they actually cultivate land in the mountains. In fact there are none, except them that are trained by mining crew that know how to fish and live by the sea. Mamanwa are more skilled to survive in the tropical forests.

On the two previous pictures above you can see their new settlement by 2009, which we proudly presented as a new beginning. It was on acceptable distance from their cultivations. In 2012, only three years later, the new settlement is a ruin, a disaster, and confusion why they lost houses, school and teacher at once.

"It is all in the papers" involved politicians, mining company and NCIP officers say, but "we know no papers" say Mamanwa, since not many are skilled with reading abilities.

The treatment by Taganito is not alone when it comes to strike against tribal and their indigenous rights.

In Carrascal, no efforts have been made to restore destroyed buildings, too, a multipurpose house which is used as a school as well.

Local politicians point to that it is the mining companies which operates locally in the town's surroundings which should cover such costs and not taken from the balance of the LGU.

This gives in our eyes that it is apparent how much more support tribal on Mindanao need. It is too important to remember that such support goes hand in hand with a broader trade and education which is profitable for all involved. No matter if it is about tribal, average population, politicians or companies. It must be an existence of common agreements on the content of coming development.

Beside this, taxes must be understand to be paid in common by the entire population in a country and shared to its local belonging depending on governmental agreements, and not as proclaimed at the Village Hall's wall in Adlay, Carrascal that "This Barangay Hall has been made possible to build by taxes paid by NN Mining Corporation"!

FTMW continues its development



During the fall of 2012, we have succeeded to give additional education and assistance to children to attend school education. Both own education given to elder and younger, but too, assistance to children to attend elementary school education under the umbrella of Department of Education.
